ENTRANT AGREEMENT:

I, the undersigned artist, hereby declare my intention to exhibit my artwork, as described in my SlideRoom entry form, at the Phoenix Village Art Center and their Annex at the Phoenix Village Apartments. Work to be delivered on **Tuesday, April 4th, 2017 between Noon and 7pm and remain until either May 2nd or July 11, 2017 depending on which gallery my work is chosen for.** I hereby represent that I am the owner of the artwork being submitted by me both as to the artwork's physical manifestation and the copyright of my artwork. I accept full responsibility for any and all damage, loss, theft and/or any other casualty of any kind to my artwork in transit to and from Phoenix Village Art Center. I hereby waive any and all claims I may have against Phoenix Village Art Center, the Annex its employees, officers, directors and committee personnel and the AE board of directors. I understand that my work may not be hung if it fails to meet minimum professional presentation standards or arrives damaged. By entering the Artists Equity "Phoenix Duo" show I understand and agree to all conditions set forth in this prospectus. **Submission to SlideRoom site counts as a signature.**

ELIGIBILITY: All members of Philadelphia Tri-State Artists Equity are eligible. Our records must show that your membership dues are current in order to participate. There is never an entry fee for AE exhibits. Visit www.artistsequity.org for a membership application.

New members are welcome to submit; however; if you are not a current AE member you must contact the exhibition chair to begin the membership process in order to submit work via SlideRoom.

SELECTION PROCEDURE: You will be notified of acceptance by email or phone by March 10th, 2017

SALES: The Phoenix Village Art Center will process all retail sales of AE artwork, and will retain 30% of retail sales for all work sold.

PUBLICITY: Unless otherwise specified, AE and The Phoenix Village Art Center reserve the right to reproduce work for the purposes of promoting this and future exhibits.

ARTWORK SPECIFICATIONS:

Painting, photography, sculpture, works on paper, mixed media and fabric art are eligible. Work must be recent and not have been exhibited previously in any AE exhibit. 2D work must be professionally presented, properly prepared for hanging and dry. Work may not exceed 5' in width including the frame. No clip frames or unframes are permitted. 3D work must be sturdy and stable. Artists are responsible for supplying their own floor pedestals for 3D work.

AE and The Phoenix Village Art Center reserve the right to reject any entries that do not meet specified requirements. Dangerous, damaged or poorly prepared work will not be accepted. No late entries. Accepted work must remain for the duration of the exhibition.

A signup sheet for the Friday opening you'd like to attend will be provided at delivery.

ALL WORK IN THE GALLERY MUST BE REMOVED BY 7PM MAY 2ND, 2017

ALL WORK IN THE ANNEX MUST BE REMOVED BY 7PM July 11, 2017
